Addendum No. 2 San Augustine Community Ditch Pipeline Project Phase III

This addendum is issued to reflect the following changes to the contract documents dated October 21, 2024. This Addendum is effective February 6, 2025. It shall be the responsibility of all bidders to adhere to any changes or revisions to San Augustine Community Ditch Pipeline Project Phase III as identified in this Addendum No. 2. This documentation shall become a part of the Contract Documents.

The purpose of this Addendum No. 2 is to post the February 6, 2006 pre-bid meeting sign-in sheet of attendees and to provide clarification and correction to the contract documents.

1. Invitation to Bid, Page 1-1; the first line of the fourth paragraph contains a typographical error. The fourth paragraph is deleted and replace with the following language. The difference is the change of "four (5)" to read "four (4)".

Contractors are invited to submit a Base Bid (for 710 linear feet of irrigation pipeline, four (4) turnout assemblies and related fittings and work), an Additive Alternative and a Deductive Alternative as listed on the Bid Proposal (page 2-1).

2. Bid Proposal, page 2-1: The description of the Bid Item 12 (Additive Alternative) is deleted and replaced with the following language. The purpose is to remove reference to (HP Storm Pipe). All project pipe shall be ADS N-12 WT pipe. A REVISED BID PROPOSAL SHEET IS ATTACHED. Bid Item 12 should read:
